ONE-DAY-PER-WEEK OUTDOOR IRRIGATION

The Southwest Florida Water Management District's (District) Governing Board voted Tuesday, May 23, 2017, to tighten water restrictions throughout the District's 16-county region.

ONE-DAY-PER-WEEK OUTDOOR IRRIGATION - BEFORE 8 AM or AFTER 6 PM

MODIFIED PHASE III WATER SHORTAGE RESTRICTIONS June 5, 2017 - August 1, 2017

Florida's dry season runs October through May. District hydrologists indicated there is an 11-inch rainfall deficit since the start of the dry season last October.

This is the driest dry season in the past 103 years.

Plant City water use restrictions and water conservation measures are established by adopting and utilizing District rules and directives

WATERING TIMES: BEFORE 8 AM or AFTER 6 PM

Outdoor Irrigation Restrictions apply to all users of water within the corporate limits of the City and all water sources. Public or private water systems, all wells and surface waters

Homeowner associations and other entities must suspend any requirement to replace lawns, pressure wash or engage in other activity which increases water usage during the water shortage declaration

NEW LAWNS & LANDSCAPE - 60-DAY ESTABLISHMENT PERIOD

Begins the day new plant material is installed.

Limited to areas containing new plant material ONLY.

An entire zone of an irrigation system may only be used for establishment period watering if the zone in question contains at least 50% new plant material.

On the day of installation, new plant material may be watered ONCE, on any day...at any time. <u>ESTABLISHMENT PERIOD WATERING IS PROHIBITED BETWEEN 8 AM AND 6 PM</u>

31-60	EVEN: TUESDAY, THURSDAY, SUNDAY

FLORIDA LAW requires any person who purchases and installs an automatic irrigation system must install, maintain and operate technology which inhibits or interrupts operation of the system during periods of sufficient moisture.



An example is a RAIN SENSOR

HAND- WATERING & MICRO-IRRIGATION of landscape plants (other than lawn) is allowed on any day at any time, if needed

Remember, use an automatic shutoff nozzle when using a garden hose.

An unattended garden hose can waste over 400 gallons of water an hour.

An automatic shutoff nozzle reduces water usage with a garden hose by an estimated 60%





VEHICLE WASHING

- Once-per-week on the designated watering day for the location.
- Commercial car washes, including mobile detailing businesses, may operate on any day.
- Emergency and other first responder vehicles may be washed on any day, as needed.
- Fundraising events are prohibited unless they were scheduled prior to the enactment of the Modified Phase III Water Shortage Order.

PRESSURE WASHING

- Annual pressure washing for aesthetic purposes is allowed.
- Pressure washing of driveways and sidewalks for necessary purposes, such as prior to painting or sealing, in order to maintain a paint or material warranty, to address a health or safety hazard and to meet federal, state or local health or safety standards *is allowed*.

FOUNTAINS & OTHER AESTHETIC WATER FEATURES

Operate only eight hours per day.

Hours of operation can be selected by the owner. Hours must be posted.

COMMERCIAL, INDUSTRIAL and AGRICULTURAL

Follow published industry standards, best management practices and water conservation practices. Such users governed by a water use permit, shall continue to comply with all permit conditions and terms.

RECLAIMED WATER irrigation is allowed on any day, except between 10 AM and 4 PM.

IRRIGATION SYSTEM EVALUATIONS
Provided by the City of Plant City.
Free for Plant City residential utility customers.

TURN OFF the water when brushing teeth or hand-washing dishes.

A leaking toilet can waste up to **200 GALLONS A DAY. REPLACING** the flapper will take care of some toilet leaks.

INSTALL low-flow faucet aerators and showerheads. Some low-flow showerheads use less than **3 GALLONS A MINUTE**.

IRRIGATE only on allowable watering day(s), during allowable times.
